

CERTIFICATE OF CONFORMITY

TRADING WITH RUSSIA AND THE EURASIAN ECONOMIC UNION

Exporters/Importers trading with Russia and EurAsian Economic Union (EAEU) countries need to comply with certain certification requirements including EAC (former Gost-R) Certificate of Conformity (CoC), Declaration of Conformity or State Registration Certificate, depending on the goods you are trading. Failure to present the correct certification can result in severe delays in goods clearance, penalties or even shipments being returned.

Current regulation concerns not simply Russia, but also other member states of the EAEU, former Customs Union – Belarus, Kazakhstan, Armenia and Kyrgyzstan. EAEU countries set up obligation to comply with single or national regulations and standards for imported good. The programme covers a wide range of products such as industrial equipment, electrical devices, textiles, toys, cosmetics and food.

The main objectives of this certification programme are the protection of safety, health and environment of people in Russia and EAEU.

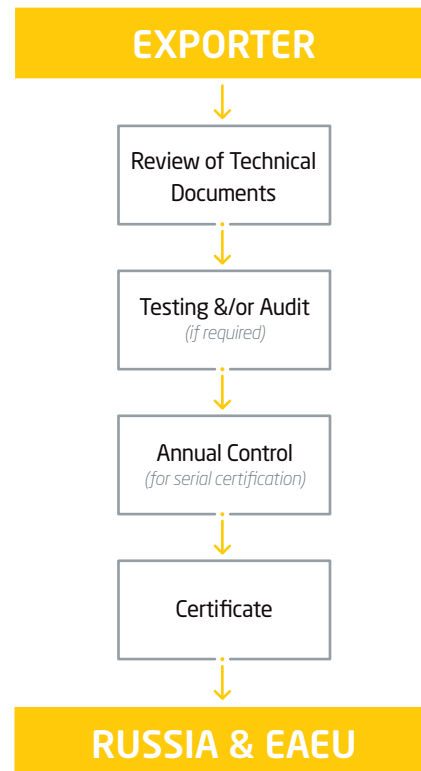
The requirements include:

- Every consignment of imported goods which contains regulated products must be accompanied by the correct CoC. These certificates can only be issued by certification bodies accredited by local competent authorities.
- CoC is required to ensure smooth customs clearance of shipments in Russia & EAEU.
- CoC confirms that the products comply with Russian and/or EAEU standards and requirements for safety.

Most common applicable certificates (not limited to) are:

- EAC / CU TR Certificate of Conformity
- EAC / CU TR Declaration of Conformity
- State Registration Certificate
- Fire Safety Certificate
- Pattern Approval Certificate
- FSS Notification by Federal Security Service
- Exemption Letter
