# **EXPORTER AND IMPORTER GUIDELINES**INDONESIA VPTI

### **OVERVIEW**

Exporters/Importers trading in Fishery Products to the Republic of Indonesia need to comply with KSO Suconfindo - Surveyor Indonesia (KSO SCISI) requirements.

Intertek International Limited has been appointed as Surveryor Partner by KSO SCISI to conduct Import Verification or Technical Inquiry of Fishery Products in the Ports of Loading (POL) of Myanmar, Philippines and Taiwan prior to their shipment to the territories of the Republic of Indonesia.

As a Surveryor Partner, Intertek International Limited will carry out import verification or technical inquiry at the Ports of Loading (POL) of Myanmar, Philippines and Taiwan, of all the Fishery Products that are covered under the Regulation 66/2018 of the Minstry of Trade and are exported to The Republic of Indonesia.

# PRODUCT COMPLIANCE



## **Indonesia Requirements**

The importer of the Fishery Products must have the following Identification numbers from the Ministry of Trade of The Republic of Indonesia

#### **Registration with Indonesia authorities**

Fishery Products that can be imported under the Verification Programme or Technical Inquiry can be imported by the following registred importers:

- API-P Producer Importer Identification Number. This is applicable for those importers of Fishery Products performing business in the industrial sector using raw/ auxiliary materials of Fishery Products.
- API-U General Importer Identification Number. This is applicable for those importers of Fishery Products of raw/ auxialiary materials for the fish processing industries, including those that do not carry out importation of Fishery Products on their own as evidenced by a booking contract.
- API Importer Identification Number. This
  is applicable to those importers belonging
  to the below group that import Fishery
  Products other than to to meet the needs
  of industrial raw/auxiliary materials:
  - State-Owned Enterprises
  - Regional-Owned Enterprises and/or
  - Private-owned enterprises

#### **Import Approval Permit**

The registred importer needs to obtain Import Approval which is a permit to import their Fishery Products. This Import Approval includes the following minimum information:

- quantity of Fishery Products
- type of Fishery Products & Tariff Heading/HS
- port of Loading
- country of origin
- port of destination
- validity period of the Import Approval

#### Recommendation

The registered importers of Fishery Products should obtain Recommendation from the Ministry of Trade which is a written statement of the technical description of Fishery Products to be imported.

#### **Marking and Labelling Requirements**

Labelling is mandatory for packaged goods.
The label should indicate as a minimum the
name of the goods (general name, trade
name, scientific name), net weight, and
name and address of exporter or importer
written in Bahasa Indonesian and English
languages. For unpackaged goods or bulk
consignments the label information above
should be included in the documentation
(proforma invoice and packing list) and
written in Bahasa Indonesian and English
languages.

# **Exempted Consignments of Fishery Products**

The provisions in this Ministerial Regulation shall not apply to imports of Fishery Products which are:

- goods of foreign country representatives;
- goods for government purposes;
- sample goods weighing at most 25 kilograms;
- passenger personal property weighing at most 25 kilograms; and
- goods for research purposes by considering certificates from relevant agencies.

## Prohibition of Transfer of Imported Fishery Products under VPTI

An API-P holder company is prohibited from trading and/or transferring Fishery Products that have been imported to other parties.

**Note:** Exporters are advised to contact local Intertek Offices for more information on exempted, prohibited, banned or restrcted fisheryproducts under VPTI.







## **CERTIFICATION PROCESS**

The Fishery Products to be exported to The Republic of Indonesia will undergo import verification/technical survey. Consignments meeting the KSO SCISI requirements shall be issued with an HPL (Hasil Pemeriksaan Lapangan) Inspection Report by Intertek and LS (Laporan Survey) Surveyor Report by KSO SCISI which can be used to clear the consignments on a fast-track basis at the Customs upon its arrival at the ports/ borders of the Republic of Indonesia.

#### IMPORT VERIFICATION PROGRAMME STAGES

Importer Applies Verification Request through KSO SCISI Portal & chooses Intertek as Surveyor Partner

KSO SCISI Approves Verification Order

Intertek receives Import Verification Order (VO)

Intertek contacts the Exporter & Schedules Inspection

Consignment Inspection and if applicable, Container Sealing

Intertek submits the HPL (Hasil Pemeriksaan Lapangan) Inspection Report to KSO SCISI

Issuance of LS (Laporan Survey)

### **Verification Order**

Intertek will review the Verification Order (VO) and will contact the exporter for scheduling of inspection.

#### Inspection

Intertek as Surveryor Partner will perform inspection of the Fishery Products that includes verification of the type and specification of goods, product labeling, packaging, and other necessary markings and physical requirements.

### **Sealing**

FCL consignments of Fishery Products shall be sealed using Intertek's seal and the shipment must not be tampered with after sealing

# Submission of HPL (Hasil Pemeriksaan Lapangan) Inspection Report

Inspection results will be submitted electronically to KSO SCISI.

### Laporan Survey (LS) / Surveyor Report

Fishery Product Consignments that comply with Inspection will be issued a Surveyor Report which will help the importer in clearing the shipment at the Customs of The Republic of Indonesia.

## **FEES FOR CAP**

The party applying for import verification technical inquiry is responsible for the payment of charges to KSO SCISI. The fees include the cost of inspection, evaluation, and all other technical and administrative activities involved in the import verification/technical inquiry.


