Hazard Involved

Insulation between the mains connection and the conductive hot plate is insufficient. Consequently the hot plate could become live, leading to the user receiving an electric shock if inadvertently touched. The product was sold online, in particular via eBAY.

What To Do

Use of these products should be immediately discontinued and return to the point of purchase.
