5.20.6		Equipment having plumbing connections or liquid reservoirs that is intended to be sealed to the floor or counter shall be designed and manufactured to prevent entrapment of liquids beneath the equipment if internal leakage were to occur.
5.20.7		 Equipment designed and manufactured to be sealed to the floor or counter shall be provided with written installation instructions that include the following: A statement indicating the equipment is required to be sealed to the floor or counter to establish proper sanitary operation; and Procedures for how the equipment is intended to be sealed to the floor or counter, indicating any recommended sealing materials and mounting surface characteristics; and A statement indicating that once sealed in accordance with these procedures, the result is intended to prevent liquid spillage on adjacent surfaces of the floor or countertop from passing under inaccessible portions of the equipment.
