# Trading with Uganda

Helping you comply with export and import requirements

Exporters/Importers trading with Uganda need to comply with the requirements of the Uganda National Bureau of Standards (UNBS) in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties or even shipments being returned to the country of export.

The Uganda PVoC has been implemented (effective December 2012) to assure Ugandan consumers of the quality and safety of imported goods and to facilitate trade. 'Regulated Products' within the programme require a Certificate of Conformity (CoC) which verifies, in the respective exporting countries, that the products comply with the applicable Ugandan technical regulations and mandatory standards or approved equivalent International/National Standards.

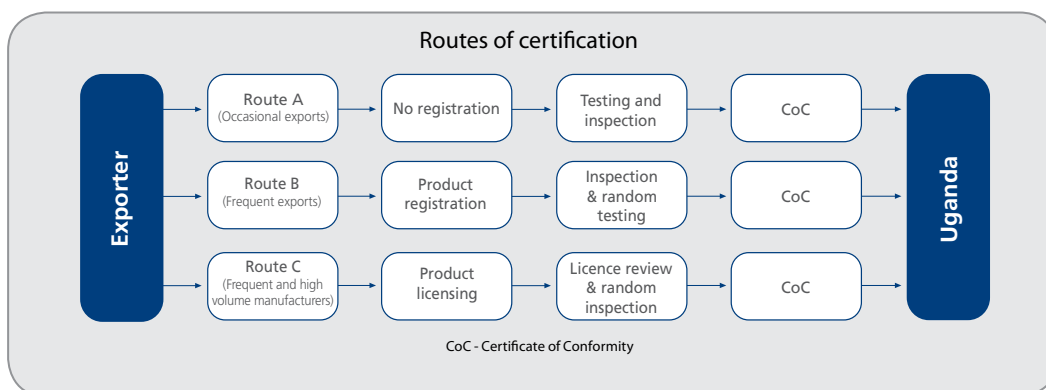




#### The requirements for Uganda PVoC include:

- Every consignment of imported goods which contains regulated products must be accompanied by a Certificate of Conformity (CoC) issued by your local PVoC Country Office prior to shipment.
- The PVoC Certificate is required to ensure smooth Customs clearance of shipments in Uganda.
- The PVoC Certificate confirms that the products comply with the relevant Ugandan technical regulations and approved standards.
- The authorities in Uganda may take random samples from imported consignments to verify compliance.
