# TRADING WITH ETHIOPIA

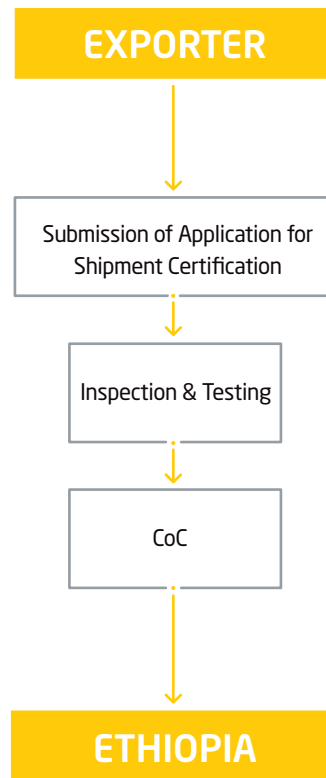
**The Ministry of Trade (MoT) of the Federal Democratic Republic of Ethiopia has imposed legal and technical regulatory requirements for certain regulated products entering Ethiopia covered in 124 Compulsory Ethiopian Standards.**

All imports of regulated products are subject to Conformity Assessment based on the review of existing certificates and valid test reports. This is followed by inspection of goods and testing where necessary and should be accompanied by a Certificate of Conformity (CoC) for Custom clearance at Ethiopian ports, Intertek has been approved by the MoT to issue exporters with the necessary CoC.

**The requirements for Ethiopia include:**

- Regulated product consignments have to be verified for compliance to relevant sanctioned standards. The compliance verification process may involve physical inspection of the consignment and, if necessary, sample selection for testing purposes.
- Testing must be carried out by accredited 17025 labs of which Intertek has a global network.
- The CoC is issued by an approved, independent, third-party inspection company, such as Intertek, prior to shipment and is required to aid smooth Customs clearance of shipments through Ethiopia Customs at border entry points.
- The list of 124 compulsory standards and regulated products fall into the following categories:
  - Measurement equipment
  - Food and beverage products
  - Textile, leather and plastic
  - Fertilizers
  - Household chemical products
  - Construction materials (such as steel, concrete, cement)
  - Electrical
- The CoC confirms that the products comply with the relevant Ethiopian technical regulations and approved standards.
