Per- and polyfluoroalkyl substances (PFAS) are a group of manufactured carbon and fluorine based chemicals, which include chemicals known as PFOS, PFOA, GenX and more. PFAS are resistant to heat, oil and water and have been used in a wide range of consumer and industrial products including protective coatings in non-stick cookware, waterproof fabrics, fast food packaging, firefighting foams, etc.
