Dear Stakeholders,

This is to inform that the above Management Unit under the Parent Company IOI Corporation Berhad with RSPO membership number 2-0002-04-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit/Surveillance Audit (ASA-04) at Pamol POM and its supply base, located at Sandakan, Sabah. The audit will be conducted from 11 - 15 August 2025 against the requirements of:

- Malaysia National Interpretation (MYNI) 2019
- RSPO Principles & Criteria 2018


