Invitation to comment on MSPO Annual Surveillance Assessment (ASA-01) of Genting Plantations Berhad, Plantation Management Unit – Genting Jambongan Oil Mill, Sabah, Malaysia

Genting Plantations Berhad has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, Genting Jambongan Oil Mill against the requirement of the Malaysian Sustainable Palm Oil Standards series, MSPO 2530:2020-3.2 General principles for organised smallholder (above 500ha) and MSPO 2530:2020-4.1 General principles for palm oil mill.

Intertek Certification International plans to conduct the Annual Surveillance Assessment (ASA-01) of Genting Plantations Berhad, Plantation Management Unit, Genting Jambongan Oil Mill on 7 – 11 July 2025

In ensuring that the organization continues to meet MSPO certification scheme requirements and in obtaining the feedback, Intertek Certification International Sdn Bhd would like to invite interested parties to comment on the assessment of Genting Plantations Berhad, Plantation Management Unit, Genting Jambongan Oil Mill. The certification unit are located at Sabah, Malaysia.

In brief, Genting Plantations Berhad (“Genting Plantations” or “the Company”) was incorporated as a private limited company on 29 September 1977. It commenced operations in 1980 as the plantation arm of the Genting Group, founded by the late Tan Sri Lim Goh Tong, and in 1982. Since the commencement of operations, Genting Plantations has successfully transformed itself from a modest, predominantly rubber-based enterprise into one of the region’s leading oil palm plantation groups. Starting with a mere 13,700 hectares in West Malaysia in 1980, Genting Plantations’ landbank has increased by leaps and bounds to 243,000 hectares currently, spread over Malaysia and Indonesia..
