CERTIFICATE OF CONFORMITY IN SRI LANKA

Sri Lanka's cosmetic products is regulated under the Cosmetics, Devices and Drugs Act No. 27 of 1980. Product compliance with the National Medicines Regulatory Authority (NMRA) is mandatory for both imported and locally manufactured cosmetics. Additionally, all imported cosmetics must meet the Sri Lanka Standards Institution (SLSI) requirements before they enter the market.

Sri Lankan regulatory landscape

All cosmetics imported or manufactured in Sri Lanka must comply with the National Medicines Regulatory Authority (NMRA) regulations to ensure consumer safety and product quality. Registration with NMRA requires detailed documentation, including product formulations, safety assessments, and labelling compliance. This process also involves compliance with Sri Lanka Standards Institution (SLSI) guidelines to ensure that products meet national quality benchmarks.

SLSI compliance

The SLSI and NMRA regulate the cosmetics industry to ensure product safety and consumer protection. Compliance with these regulatory bodies includes:

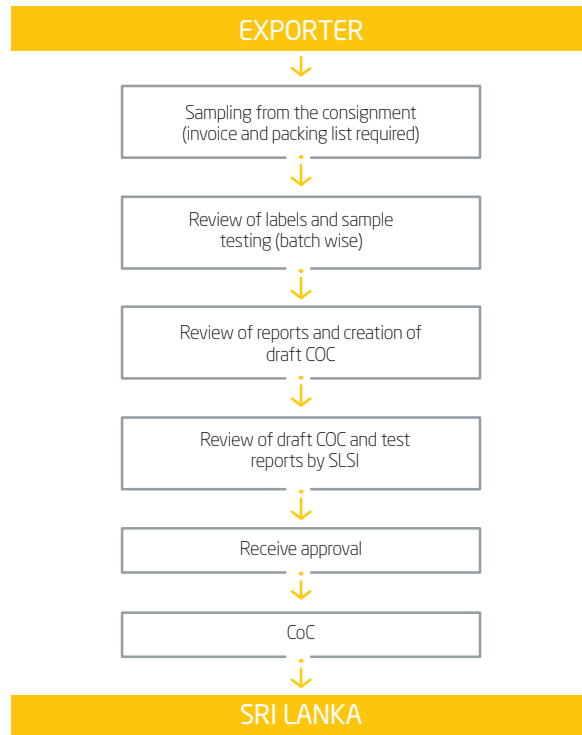
- NMRA registration for all cosmetics locally manufactured or imported prior to selling in Sri Lanka.
- SLSI standards compliance to meet Sri Lanka's national quality and safety benchmarks.
- Labelling and packaging regulations to ensure mandatory product information compliance with Sri Lanka's regulations and standards.

Non-compliance with these regulations can result in import delays, penalties, or product rejection at Sri Lankan ports.

CoC - Certification of Conformity
