COUNCIL OF MINISTERS

Decree No. 8/2022 of 14 March

There being the need to revise Decree No. 59/2009, of 8 October, which approves the Regulation on Standardization and Conformity Assessment, in order to conform it to the new normative and regulatory requirements of standardization and conformity assessment and under the scope of paragraph f) of No. 1 of article 203 of the Constitution of the Republic, the Council of Ministers determines:

Article 1. The Regulation on Standardization and Conformity Assessment, annexed to this Decree and which is an integral part thereof, is hereby approved.

Article 2. It is incumbent upon the Minister who oversees the area of industry and commerce to approve the standards for the application of the present Decree.

Article 3. Decrees No. 59/2009 of 8 October and No. 19/2010 of 30 June are hereby revoked.

Article 4. This Decree enters into force on the date of its publication.

Regulation on Standardisation and Conformity Assessment

CHAPTER I

General provisions

ARTICLE 1

(Definitions)

The meaning of the terms used in this Regulation is set out in the glossary annexed hereto and which forms an integral part thereof.

ARTICLE 2

(Object)

This Regulation establishes the Legal framework for standardization activities and conformity assessment.

ARTICLE 3

(Scope of application)

This Regulation shall apply to the process of preparation, approval, homologation and publication of Mozambican technical regulations and Technical Standards, as well as to conformity assessment activities.

ARTICLE 4

(Objectives)

The objectives of this Regulation are to:

- a) promote the use of the Mozambican Technical Standards;
- b) promote and ensure conformity assessment activities;
- c) simplify and enable the interchangeability and compatibility of products, processes, and services;
- d) facilitate communication between supplier and consumer;
- e) protect the consumer from unfair commercial practices;
- f) ensure fair competition;
- g) promote equal treatment for domestic and imported products;

- h)* stimulate quality improvement;
- i)* promote international trade and cooperation;
- j)* preserve national security imperatives;
- k)* protect human health, safety, and the environment;
- l)* adding value to Mozambican brands;
- m)* facilitate Mozambique's insertion in international trade;
- n)* remove technical barriers to trade;
- o)* ensure the circulation in the country, of products that are in conformity with the standards and technical regulations; and
- p)* establish conformity assessment programs and ensure the quality control of national and imported products marketed in the country.

CHAPTER II Stakeholders and Competences

ARTICLE 5

(Stakeholders)

The stakeholders involved in standardization and conformity assessment activities are:

- a)* Ministries;
- b)* Public institutes;
- c)* Companies;
- d)* Universities;
- e)* Laboratories;
- f)* Economic, professional, and research associations;
- g)* Consumer protection associations;
- h)* Non-Governmental Organizations; and
- i)* Natural persons.

ARTICLE 6 (Competences)

1. The National Institute for Standardization and Quality (INNOQ, IP) is, in particular, responsible for:

- a)* coordinating and developing standardization activities in the country together with other stakeholders;
- b)* managing the national mark of conformity;
- c)* designating conformity assessment bodies to use the national conformity assessment mark on the products assessed;
- d)* recognizing the technical competence of conformity assessment bodies, as long as the accreditation body has not been established;
- e)* implementing Mozambican Technical Standards that underpin the technical regulations prepared by the entities with legal regulatory competence;
- f)* deciding on the delegation of powers to other public and private entities, through a process of prior qualification;
- g)* checking the conformity of domestic and imported products;
- h)* carrying out technical inspection activities on equipment;
- i)* certifying the conformity of management systems, products, processes, services and people with the Mozambican Technical Standards and in their absence with the International Technical Standards;
- j)* developing and managing Conformity Assessment Programs; and
- k)* establishing guidelines and criteria for Standardization and Conformity Assessment Activities.

2. The competences of other stakeholders are defined in their respective by-laws.

CHAPTER III Mozambican Technical Standards

ARTICLE 7

(Status of Mozambican Technical Standards)

1. The Mozambican Technical Standards are voluntary and their application depends on the need for their use.

2. Mozambican Technical Standards acquire a mandatory character when they are the basis for technical regulations or a general law, aimed at achieving a legitimate objective.

ARTICLE 8 (Development)

1. Mozambican Technical Standards (NM) are developed on the basis of international standards, except where such international standards or their main elements are an inappropriate or ineffective means for the achievement of legitimate objectives.

2. The Mozambican Technical Standards (NM) are developed by the Technical Standardization Commissions (CTN), the Technical Standardization Sub commissions (SCTN) and the Standardization Working Groups (GTN), whose composition comes from the stakeholders referred to in article 5 of the present Regulation.

3. When there are no Mozambican Technical Standards for a given product, process or service, the regulatory authority shall request INNOQ, IP to develop them.

4. INNOQ, IP, shall invite all interested parties to participate in the Technical Standardization Commissions (CTN), the Technical Standardization Sub-Commissions (SCTN) and the Standardization Working Groups (GTN).

ARTICLE 9 (Approval, homologation, edition and publication)

1. Mozambican Technical Standards are approved by the Sectoral Technical Standardization Commission (CTNS).

2. The Mozambican Technical Standards are homologated by the head of INNOQ, IP, and the homologation list is published in the III Series of the *Bulletin of the Republic*.

3. The Mozambican Technical Standards shall enter into force after their edition.

4. Only texts drafted in accordance with the provisions of this Regulation shall be considered Mozambican Technical Standards and presented as such to regional and international standardization organizations.

ARTICLE 10 (Analysis and revision)

1. The Mozambican Technical Standards are revised every five years, after analysis and decision by the respective technical commission.

2. The revision of the Mozambican Technical Standards is carried out before the period determined above, if the technological progress or the economic or social conditions so require, or still, at the request of the entity with regulatory competence in the matter.

3. The revision of the Mozambican Technical Standards follows the same process as their development.

4. The revision and revocation of the Mozambican Technical Standards, referred to in technical regulations, are coordinated by INNOQ, IP, with the participation of all entities with regulatory competence in the matter, which shall integrate the respective Technical Standardization Committees.

ARTICLE 11 (Intellectual Property)

1. The Mozambican Technical Standards and other normative publications developed and published in accordance with the process established by the present Regulation shall be equated to collective intellectual works, benefiting from protection under the terms of the applicable legislation.

2. The copyright corresponding to the normative publications referred to in the previous number belongs to INNOQ, IP.

CHAPTER IV Technical Regulations

ARTICLE 12 (Development)

1. Technical regulations are developed by the competent authorities in areas where the product, process or service may pose risks to the health and safety of the consumer or the environment.

2. In the development, approval and application of the technical regulations the following shall be observed:

- a) technical regulations shall be based on Mozambican Technical Standards or in their absence on harmonized Regional Technical Standards or International Technical Standards;
- b) the method of reference to standards must be followed in the development of technical regulations; and
- c) technical regulations must not constitute unnecessary technical barriers to trade.

3. All technical regulations developed in accordance with the provisions of the preceding paragraphs shall, prior to their approval, be sent to INNOQ, IP, for purposes of notification to the World Trade Organization (WTO).

4. The purpose of the notification is to make the technical regulation available to interested parties for a 60-day comment period so that, once adopted, it does not constitute an unnecessary technical barrier to trade.

ARTICLE 13 (Reference to technical standards)

The reference to technical standards is made by designating only the number and title of one or more given technical standards, so that subsequent revisions of this or these standards are applied without it being necessary to modify the Regulation.

CHAPTER V Conformity assessment SECTION I

Activities and procedures

ARTICLE 14 (Activities)

1. Conformity assessment activities shall take account of national needs, be non-discriminatory, transparent, avoid unnecessary technical barriers to trade and be based on technical regulations and standards.

2. Conformity assessment activities may be carried out by:

- a) first party: when it is made by the supplier;
- b) second party: when it is made by the purchaser or consumer; and
- c) third party: when it is made by an organization that is independent from the supplier and the purchaser or consumer and has no interest in marketing the product.

3. The conformity assessment procedure is mandatory for suppliers of products, processes and services when it relates to a technical regulation.

4. When the conformity assessment procedure is related to Mozambican Technical Standards, it is voluntary.

5. The conformity assessment procedures are part of the mandatory control product conformity assessment programs.

6. The Conformity Assessment Activities for national products are carried out by public entities with competences defined in specific legislation.

ARTICLE 15 (Conformity assessment procedures)

1. In conformity assessment procedures based on technical standards and regulations, the granting of licenses, certificates and marks must be established according to the characteristics of the product, process or service to be assessed.

2. It is the obligation of suppliers to make their goods subject to the conformity assessment mechanisms laid down in the conformity assessment procedures.

3. The following mechanisms may be used in conformity assessment procedures:

- a) Supplier's declaration of conformity;
- b) Certification;
- c) Inspection;
- d) Labelling; and
- e) Testing.

4. The conformity assessment procedures are described in the Portuguese Language.

5. The conformity assessment procedures, when mandatory, shall be established by the entity with regulatory competence in partnership with INNOQ, IP, in order to be granted the right to use the national mark of conformity.

6. The conformity assessment procedures, when voluntary, shall be established by INNOQ, IP.

SECTION II

Conformity assessment programs

ARTICLE 16 (Conformity assessment programs)

1. All imported products are subject to the conformity assessment program, the conformity assessment of which is mandatory, in accordance with the list of mandatory control products annexed to this Regulation, and which is subject to updating whenever reasons of public health, safety or the environment so dictate.

2. All products covered by the Conformity Assessment Program shall be assessed and approved based on the Mozambican Technical Standards on quality, technical regulations or other technical specifications adopted by INNOQ, IP.

3. The technical specifications applicable to the Conformity Assessment Programs for products under mandatory control are published and made available by INNOQ, IP, and by interrelated entities.

4. The conformity of the product with the technical specifications set out in this article is demonstrated by displaying the conformity mark on its label or packaging, or through a conformity certificate issued by an entity selected by INNOQ, IP, which must be produced to the Customs Authorities at the time of entry into the Country.

5. The list of mandatory control products is subject to periodic updates based on the analysis of the risk that each product represents for public health, the environment and safety, and must be approved by Ministerial Order, by the Minister that oversees the area of Industry and Commerce, and published in the *Bulletin of the Republic*.

6. Products covered by this Regulation, when imported, may be subject to inspection on entry into the Country.

ARTICLE 17 (Conformity assessment procedures for imported products)

The procedures within the scope of the conformity assessment programs are described and approved by INNOQ, IP, and cover the following activities:

- a) physical inspection prior to shipment;
- b) sampling, testing and analysis in accredited laboratories;
- c) audits to assess the degree of implementation of technical standards relating to product manufacturing processes; and
- d) analysis or documentary verification and assessment of conformity with the requirements of the applicable standards and/or regulations.

ARTICLE 18 (Conditions for authorization)

1. The conditions required for an entity to be authorized to represent INNOQ, IP, in the execution of Conformity Assessment Programs are the following:

- a) professional competence and qualified personnel;
- b) equipment and infrastructure that meet the requirements for conformity assessment, including an international network of accredited laboratories;
- c) independence and impartiality in the conformity assessment procedure;
- d) interoperability capability and the establishment of a communication platform for INNOQ, IP to verify conformity anywhere in the world in real time; and
- e) confidentiality.

2. For the purpose of paragraph 1 of the present article, the selection of the entity is made through a public tender.

3. INNOQ, IP maintains the register and publishes the Conformity Assessment Bodies authorized to represent it in the newspaper with the greatest circulation.

ARTICLE 19 (Supervision)

When the product has been shown not to conform to the essential requirements, the costs arising from the supervision of the Conformity Assessment activities under the Conformity Assessment Programs are the responsibility of:

- a) importers; and
- b) local producers and packers.

SECTION II

Conformity Marks, Certificates of Conformity and Licenses

ARTICLE 20 (Conformity marks, certificates of conformity and licenses)

1. The conformity of products, processes or services with technical standards and regulations is evidenced by conformity marks and certificates.

2. It is incumbent upon the Minister who oversees the industry and commerce sector to approve the national conformity mark, which ensures conformity with the requirements established by the technical standards and regulations, whose mechanisms and conditions are defined in the respective conformity assessment procedures.

3. The management of the national mark of conformity is the responsibility of INNOQ, IP.

4. The national mark of conformity is protected by the legislation in force.

5. Certificates of conformity and licenses are issued as part of the Conformity Assessment Activities carried out according to the established procedures and applicable legislation.

CHAPTER VI Supervision, Fees, Infringements and Sanctions

ARTICLE 21 (Inspection)

1. Without prejudice to the other entities with supervisory functions, it is the responsibility of the entity that oversees the areas of economic activities to supervise compliance with the provisions of this Regulation.

2. The supervisory body referred to in the previous paragraph may, in the exercise of its functions, request the collaboration of judicial, public security or administrative authorities.

ARTICLE 22 (Fees)

1. Fees are due for the Conformity Assessment Activity under the terms of this Regulation.

2. It is incumbent upon the Minister of Finance and the supervising Minister of the area of activity to approve, by joint Ministerial Order, the fees referred to in the preceding number, as well as the destination to be given to the respective revenues.

ARTICLE 23 (Infringements)

Without prejudice to the infringements foreseen in the general law, the following shall constitute infringements of the present Regulation:

- a) the partial or total reproduction of the Mozambican Technical Standard made by an entity other than INNOQ, IP;
- b) the undue use of the certificate, license or mark of conformity for a purpose other than that for which it is intended;
- c) the adoption of conduct or omissions that mislead or constitute a practice that is likely to mislead the consumer;
- d) the hindrance or obstruction of an agent in the exercise of his or her powers;
- e) the substantial modification of a product, process or service which has been subject to a conformity assessment, without prior notice to the competent authority;
- f) the declaration or display of the condition of being certified to perform a specific work, activity or function, in cases where the corresponding certification has not been granted;
- g) the use of the expired certificate or license;
- h) the failure to subject products to the conformity assessment procedures laid down in the technical regulations;
- i) the use of Conformity Assessment Programs that are not described in the Portuguese Language;
- j) the placing by any company, other legal person or an entrepreneur of a product in circulation that:
 - i. does not conform to approved technical standards or regulations in respect of intrinsic characteristics;
 - ii. has not been assessed for conformity in accordance with an approved procedure;
 - iii. is not marked in accordance with the established technical requirements, or is not accompanied by the respective approval documents;
 - iv. bears a conformity mark or any other mark similar to the approved conformity mark, without conforming to approved standards or technical regulations as regards intrinsic characteristics; and
 - v. is presented with a conformity assessment mark carried out by an administrative authority or a legal person without being authorized for that purpose.

ARTICLE 24 (Sanctions)

1. Without prejudice to the sanctions provided for in the legislation in force, and to the corresponding civil or criminal liabilities, the violation of the provisions of the present Regulation shall be subject to administrative sanctions and shall be punishable by a fine according to the nature of the infraction.

2. The accumulation of infringements is sanctioned by adding the corresponding fines.

3. The infractions provided for in article 23, for the activity of standardization and conformity assessment, shall be graded as follows:

- a) a fine corresponding to 50 minimum wages in case of violation of the provisions of paragraphs a), b), c) and d);
- b) a fine corresponding to 75 minimum wages in case of violation of the provisions of paragraph e);

- c) a fine corresponding to 100 minimum wages in case of violation of paragraphs f) and g);
- d) a fine corresponding to 200 minimum wages in case of violation of the provisions of paragraph h);
- e) a fine corresponding to 50 minimum wages in case of violation of the provisions of paragraph i);
- f) a fine of 250 minimum wages, seizure and destruction of the product in case of violation of the provisions of sub-paragraphs i) and iv) of paragraph j);
- g) a fine of 200 minimum wages and payment of the reassessment costs in the event of infringement of the provisions of subparagraphs ii), iii) and v) of paragraph j).

4. For the purposes of this Regulation, minimum wage is considered to be the minimum remuneration of the respective activity sector.

5. Depending on the seriousness of the infraction, the sanctions of suspension, license revocation and withdrawal of the Certificate of Conformity Assessment may be applied cumulatively with a fine.

ARTICLE 25 (Seizure)

1. It is the responsibility of the entity that supervises the areas of economic activities to seize the products found in the situations provided for in subparagraph j) of Article 23 of the present Regulation.

2. Products definitively seized, by virtue of the penalty imposed, which can no longer be appealed at the administrative level, when they are not to be destroyed, are donated to social assistance programs developed by the State or to educational or social assistance institutions recognized as charitable entities, and their commercialization is forbidden.

ARTICLE 26 (Recidivism)

1. There is recidivism when the agent, to whom the sanctions related to the infractions mentioned in Article 23 of the present Regulation have been applied, commits another identical one.

2. Recidivism regarding the infractions mentioned in article 23 of the present Regulation is sanctionable by doubling the amount of the stipulated fines.

ARTICLE 27 (Payment of fines)

1. The deadline for voluntary payment of the fine is 15 days from the date of receipt of the notification.

2. The amount of the fine imposed for committing the infractions foreseen in this Regulation shall be paid at the domicile of the supervising entity.

3. In the absence of voluntary payment of the fine within the period established in paragraph 1 of this article, the entity that supervises the economic activities must extract the respective certificate of relaxation and forward it to the Private Tax Foreclosure Court.

ARTICLE 28 (Destination of the fines)

The proceeds of the fines are divided into 20% for the State Budget and 80% for the supervisory body.

Annex I

Glossary

For the purposes of this Regulation the following definitions shall apply:

1. **Accreditation:** means an assessment performed by a third party on a conformity assessment body, expressing a formal demonstration of its competence to carry out specific conformity assessment tasks.
2. **Standard document review:** means the activity of checking a standard document to determine whether it needs to be reconfirmed, modified or nullified.
3. **Audit:** means a systematic, independent and documented process for obtaining objective evidence and evaluating it to determine the extent to which audit criteria are met.
4. **Conformity assessment:** means the demonstration that the requirements specified in technical regulations or standards, concerning a product, process, system, person or organization are fulfilled.
5. **Intrinsic characteristics:** means the internal characteristics of the objects of conformity assessment (e.g., chemical, microbiological and physical properties, among other quality determinants).
6. **Certification:** means the assessment of products, processes, systems or people carried out by a third party.
7. **Certificate of Conformity:** means a document issued in accordance with the rules of the subsystem of conformity assessment, providing confidence that a product, process or service duly identified is in conformity with the requirements specified in technical regulations or standards.
8. **Putting a Product into Circulation:** means selling, offering for sale or entering into any other commercial or industrial transaction involving a product or industrial equipment, for the first time.
9. **Technical Standardization Commission (CTN):** means a permanent commission, responsible for developing, revising and correcting the Mozambican Standards (NM) for a specific area of activity.
10. **Sectoral Technical Standardization Commission (CTNS):** means a permanent commission, responsible for the planning, coordination, assistance and control of all the work involved in the development of the NM for a specific sector of activity.
11. **Purchaser:** means any individual or legal entity that acquires or uses a product or service.
12. **Consumer:** means any natural or legal person who acquires or uses a product or service as a final recipient.
13. **Supplier's declaration of conformity:** means an assessment made by the supplier for first party that a product, process or service meets the requirements specified in a technical regulation or standard.
14. **Appointment:** means the governmental authorization of a conformity assessment body to carry out specific conformity assessment activities.
15. **Standard document:** means a document defining rules, guidelines or characteristics for activities or their results. In this context standard documents include, inter alia, standards, technical specifications, codes of good practice and directives.
16. **Testing:** means a technical operation which consists in determining one or more characteristics of a given product, process or service according to a specified procedure.
17. **Technical Specification:** means a document that defines technical requirements that a product or equipment, process, service must comply with.
18. **World-class equipment and infrastructure:** This is world-class, first-class, high-end, globally renowned, quality equipment and infrastructure.
19. **Labelling:** means an attestation by a third party, usually through tests, in which a characteristic of the product, especially related to its performance, is determined and informed to the consumer.
20. **Supplier:** is any individual or legal entity, public or private, domestic or foreign, as well as unidentified entities, which develop activities of production, assembly, creation, construction, transformation, import, export, distribution or commercialization of products or services.
21. **Standardization Working Group (GTN):** means a working group, of an "ad-hoc" nature, which is responsible for the study of specific issues and depends on a CTN or SCTN.
22. **INNOQ, IP:** *Instituto Nacional de Normalização e Qualidade-Instituto Público* (National Institute for Standardisation and Quality - Public Institute).
23. **Inspection:** means an assessment of conformity by observation and judgement appropriately accompanied by measurement, testing or comparison.
24. **Physical inspection:** visual check of the conformity of the product under analysis.
25. **ISO:** International Organization for Standardization.
26. **License:** Document confirming that the product conforms to technical regulations and standards. In the context of the implementation of conformity assessment programs, licenses are issued to manufacturers (and any official representative) for the product categories concerned in order to confirm their ability to produce products in conformity with the Conformity Assessment Program as part of a quality management system.
27. **List of mandatory control products:** list containing the products considered to pose a risk to public health and safety and the environment, which must be subject to mandatory control;
28. **Conformity Mark:** a protected mark, applied or issued according to the rules of a conformity assessment subsystem, which indicates with a sufficient level of confidence that the product, process, or service is in conformity with a specific standard or other normative document.
29. **National Mark of Conformity:** mark of conformity applied on the basis of a technical regulation.
30. **International Standard:** means a standard that is adopted by an international standardization organization and made available to the public.
31. **Mozambican Standard (NM) or Mozambican Technical Standard:** document established by consensus and approved by the *Instituto Nacional de Normalização e Qualidade-IP* (National Institute for Standardization and Quality-Public Institute), which provides, for common and repeated use, rules, guidelines or characteristics for activities or

- their results, ensuring an optimum level of organization, in a given context.
- 32. **Regional Standard:** standard adopted by a regional standards organization and made available to the public.
 - 33. **Standard:** document established by consensus and approved by a recognized body, which provides, for common and repeated use, rules, guidelines or characteristics for activities or their results ensuring an optimum level of organization, in a given context.
 - 34. **Standardization:** activity designed to establish, in the face of actual or potential problems, provisions intended for common and repeated use, in order to achieve the optimum degree of organization in a given field.
 - 35. **Harmonized standards:** standards on the same subject adopted by different standardization bodies and which ensure the interchangeability of products, processes and services, or the mutual understanding of test results or information supplied in accordance with these standards.
 - 36. **Legitimate objective:** imperative grounds of national security, the prevention of deceptive practices, the protection of human health or safety, animal or plant health or life or the environment.
 - 37. **Conformity Assessment Body:** laboratory or network of independent laboratories, certification or inspection body, control authority or other authority that carries out a conformity assessment.
 - 38. **Conformity Assessment Organization:** organization that carries out conformity assessment services.
 - 39. **Stakeholders:** persons or organizations that have an interest in the performance or success of conformity assessment procedures.
 - 40. **Conformity assessment procedure:** any procedure used directly or indirectly to determine that the relevant requirements of technical standards or regulations are met.
 - 41. **Process:** a set of interrelated and interacting activities that transform inputs into outputs.
 - 42. **Product:** the result of a set of interrelated and interacting activities that transform inputs into outputs. There are 4 categories of product: service, software, hardware and processed materials.
 - 43. **Conformity Assessment Program (PAC):** is a conformity assessment procedure, carried out prior to shipment, used to verify that products to be imported into the country conform to the Mozambican Technical Standards, Regional Technical Standards or International Technical Standards applicable in the country.
 - 44. **Technical Regulation:** a document that establishes the characteristics of a given product or process related to it and the production methods, including the applicable administrative clauses, with which conformity is mandatory. This document may also include or deal exclusively with terminology, symbols, packaging, marking and labelling requirements and how they apply to a product, process or production method.
 - 45. **Technical Requirement:** a technical condition, requirement or obligation of a product or of a method of production or processing of such a product, including administrative provisions applicable to the product or industrial equipment which is by its nature mandatory to be fulfilled. A technical requirement may also contain or refer exclusively to terminology, symbols, requirements regarding packaging, designation and indication, if applicable to a product or industrial equipment, method of production or processing.
 - 46. **Revision:** introduction of all modifications deemed necessary to the content and presentation of a standard document.
 - 47. **System:** a set of interrelated and interacting elements.
 - 48. **Standardization Technical Sub-Commission (SCTN):** permanent commission, responsible for the development, revision and correction of the NM of specific subjects in the area of CTN of which it is a member.
