# Trading with Kenya

Helping you comply with export and import requirements

Exporters/Importers trading with Kenya need to comply with the requirements of the Kenya Bureau of Standards (KEBS) Pre-Export Verification of Conformity (PVoC) to Standards Programme in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties or even shipments being returned.

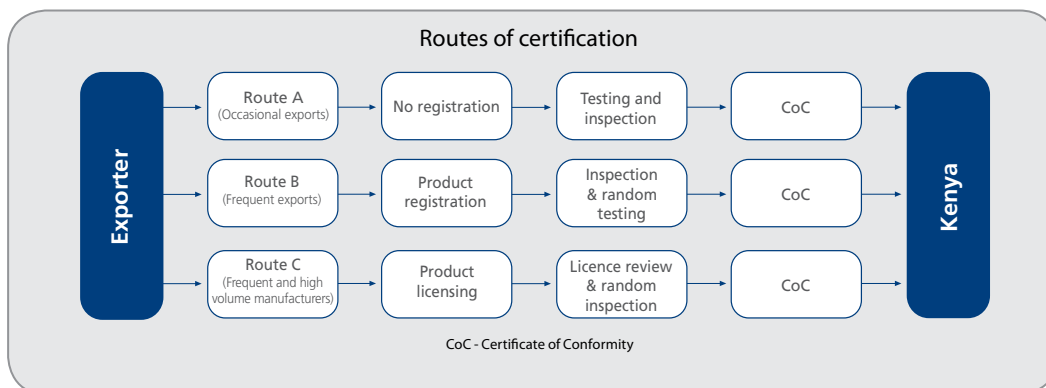
The Kenya PVoC was implemented in 2005 to assure Kenyan consumers of the quality and safety of imported goods and to facilitate trade. 'Regulated Products' within the programme require a Certificate of Conformity which verifies, in the respective exporting countries, that the products comply with the applicable Kenyan technical regulations and mandatory standards or approved equivalent International/National Standards.





#### The requirements for PVoC include:

- Every consignment of imported goods which contains regulated products must be accompanied by a Certificate of Conformity (CoC) issued by your local PVoC Country Office prior to shipment.
- The PVoC Certificate is required to ensure smooth Customs clearance of shipments in Kenya.
- The PVoC Certificate confirms that the products comply with the relevant Kenyan technical regulations and approved standards.
- The authorities in Kenya may take random samples from imported consignments to verify compliance.
